RDA Vision

Researchers and innovators openly sharing data across technologies, disciplines, and countries to address the grand challenges of society.

RDA Mission

The Research Data Alliance (RDA) builds the social and technical bridges that enable open sharing of data.

RDA Guiding Principles

The RDA is built on six fundamental values and participation is open to all who adhere to its Guiding Principles

- **Openness** – Membership is open to all interested individuals who subscribe to the RDA's Guiding Principles. RDA community meetings and processes are open, and the deliverables of RDA Working Groups are publicly disseminated.
- **Consensus** – The RDA moves forward by achieving consensus among its membership. RDA processes and procedures include appropriate mechanisms to resolve conflicts.
- **Inclusivity** – The RDA seeks to promote broad, balanced and inclusive representation of its membership and stakeholder communities.
- **Harmonisation** – The RDA works to achieve harmonisation across data standards, policies, technologies, infrastructure, and communities.
- **Community-driven** – The RDA is a public, community-driven body of volunteer members and organisations, supported by the RDA Secretariat.
- **Non-profit and technology-neutral** – The RDA does not promote, endorse, or sell commercial products, technologies, or services and the development of open and re-usable recommendations and outputs within the RDA is mandatory.

The More You Give, The More You Get: Getting Involved

**Once you have become an official member of the RDA,
you can get involved in a variety of ways**

Follow or Join a Group

You can follow or join any number of Interest and Working Groups and Communities of Practice. Once you have joined a group, you will have access to the working documents for that group, and be able to contribute to all activities.

Start a Group

You can also establish a new Working Group or Interest Group. Both WGs and IGs require a document (a Case Statement for WGs, a Charter for IGs and an Agreement for CoPs) outlining the goals, interaction with other initiatives, and expected work plan of the group; a WG is also expected to outline an adoption plan for its proposed Recommendation.

Attend Plenaries

RDA Plenary meetings are held twice a year, generally March–May and September–November. The first plenary of the year is usually fully virtual with the second one being hybrid. Locations are rotated around the world to allow participation from as many people as possible. Comment on RDA Community work

Any RDA member can provide comments and feedback on group proposals currently in RDA Community Review. They are listed in the “Requests for Comments” box on the RDA Community homepage, and will typically be available for comment for one month. Interest Group Charters, Working Group Case Statements, Community of Practice Agreements and group outputs are the most frequent activities requiring community review.

Interest Group Charters

Interest Group Charters describe a proposed Interest Group's purpose, motivation, objectives, outcomes and timelines, and undergo a 3-step review phase before the group can become a recognised and endorsed RDA Interest group. As the Community Review happens early on in the life of an Interest Group, this is a good opportunity to help shape the direction of the group.

Working Group Case Statements

Working Group Case Statements describe a proposed Working Group's purpose, motivation, objectives, outcomes and timelines, but also include the envisaged outputs and adopters of those outputs. As with Interest Groups, providing comments during the Community Review phase as part of the 3-step review process is a good opportunity to contribute to shaping the Working Group, especially if you are interested in potentially adopting the envisaged outputs.

Community of Practice Agreements

Communities of Practice (CoP) were introduced in December 2020. CoPs investigate, discuss and provide knowledge and skills within a specific discipline and/or research domain. If you are interested in a CoP's domain, providing comments on a CoP during its community review phase is a good way to get involved.

Getting Involved

Comment on Community Solutions

Working and Interest Group Outputs

There are two main types of Outputs produced by RDA groups: Recommendations, which are produced by Working Groups towards the end of their 12–18 month lifespan, and Supporting Outputs, which can be produced by both Working and Interest Groups at any time. Both Recommendations and Supporting Outputs are made available for community comment as part of the outputs endorsement process. At this point, you are particularly invited to comment on whether the output under review helps to further the RDA mission, and if it is consistent with the principles of the RDA and, for Recommendations, whether they are adoptable.

Other Documents Produced by RDA Governing Bodies

Some of the RDA bodies put out documents on various aspects of the RDA for community comment. Previous documents have included a proposal on Transparency and Openness in RDA, a document discussing some thoughts on RDA as a Standards body and, more recently, the RDA Strategic Plan 2024–2028.

Participate in RDA Governance Elections

Council and TAB members are elected yearly by the community on a rotating basis. Calls for nomination are published ahead of the elections. As an RDA member, you are eligible to vote in RDA elections and run for office if you would like to take on a larger role in the organisation. Details on the Council election process are described in the RDA Governance document, and more details on TAB elections can be found in the TAB Election Process document.

RDA Governance and Organisational Boards

- **Council** – responsible for the oversight, sustainability, and overall success of the RDA.
- **Funders Forum** – a group of funding organisations with an interest in research data and related data policies.
- **Organisational Advisory Board** – composed of representatives of the RDA's Organisational Members, advises Council on the directions, processes, and mechanisms of the RDA from an organisational perspective.
- **Regional Advisory Board** – composed of representatives of the RDA's Regional Partners, advises Council on the directions, processes, and mechanisms of the RDA for a regional perspective.
- **Technical Advisory Board** – provides technical expertise and advice to Council, as well as supporting and developing RDA groups to promote their impact.
- **Secretariat** – composed of an internationally distributed team including the **Secretary General**, conducts daily RDA operations and administrations.
