About the Research Data Alliance

Established in 2013, the RDA is a global, consensus-based, community-driven organisation of over:



13,500 individuals



77 organisational members



35 regional networks from 151 countries,

whose mission is to provide a platform to drive innovation surrounding data sharing and interoperability. The RDA enables data to be shared and re-used across geographical, technological and disciplinary boundaries, through outputs and recommendations developed by groups and volunteer experts from around the world, drawn from academia, the private sector, and government. To date over 100 Recommendations and Outputs have been developed and are openly available for implementation by all.

Organisations play a fundamental role in the RDA community

While the RDA is a member-driven organisation, its work is supported by a range of institutions around the world that make up the RDA Organisational Assembly. These institutions play an important role in guiding the work of the RDA and disseminating its outputs.

How do organisations interact within the RDA?

Organisational Members are the adopters and drivers of the RDA, providing organisational insight and vision to the community. It is a key element in RDA's funding model, ensuring sustainability, and free membership for all individuals - a vital characteristic for equitable participation. The RDA has 65 Organisational Members and 12 Affiliate members. The complete list is available on the <u>website</u>. All organisations that become RDA Organisational or Affiliate Members, join the Organisational Assembly (OA) which meets monthly by teleconference.

The **RDA** <u>Organisational Advisory Board</u> (OAB), a sub-committee of the OA, represents Organisational and Affiliate Members within the governance structure of the RDA.

- Professional societies / associations

- Other types of organisations not listed above that have an interest in furthering the goal of the RDA and intend to adopt RDA's infrastructure solutions.

How does my organisation join and how much does it cost?

Complete the <u>application forms</u> on the RDA web site. Organisations can apply via the Membership Application form (default) or the Subscription one (for Libraries or other organisations for which it is easier to pay subscriptions). Fees are annual and are pro-rated for the quarter in which they sign the organisational membership agreement (i.e. submit the on-line application form).
