




The Work of RDA performed by the global volunteer community of data practitioners enables representation of all geographies, research domains, and professional cultures.



# RDA Global Funding Investment 2013-2020 Approx. £23 million




- Total Funding Agency Investment (2013-2020)
- of which RDA Foundation (Global Secretariat) Funding (2013 -2020)


### RDA over the years: Community Growth

# RDA over the years: Organisational Membership growth











## RDA over the years: Group growth 2013: 14 groups -> 2020: 133 groups



#### RDA Foundation Total Income (2018 - 2020)










#### RDA Organisational Membership Fees / Subscriptions (2018-2020)












#### RDA Foundation Income vs Expenditure (2018-2020)









### What does RDA Global need annually?

#### **Core Funding (Systematic):**

#### £400,000

- ✓ Personnel: salaries & travel
- ✓ Fiscal expenses
- ✓ Other: web platform, office costs
- ✓ Bank Reserves

#### Nice to have (Incremental):

£100,000 - £200,000

- ✓ Increased global personnel
- ✓ Maintenance & research facility
- ✓ Helpdesk
- ✓ Awards, Scholarships, Grants

Regional grants underlying global contributions are FUNDAMENTAL to maintain and grow the community





## The Cost of NOT having RDA



- No fundamental progress towards achieving open science | open research vision.
- Guaranteed duplication of efforts.
- No open and available community-based solutions, best practices, guidelines and standards for all stakeholders to capitalize on.
- No global pool of data practitioners from multiple communities and stakeholders to call to action.
- No international cohort to support global interoperability, essential for the open science clouds, data commons that are being heavily invested in across the globe.

- Engage with regional offices / representatives to align revenue and business models


