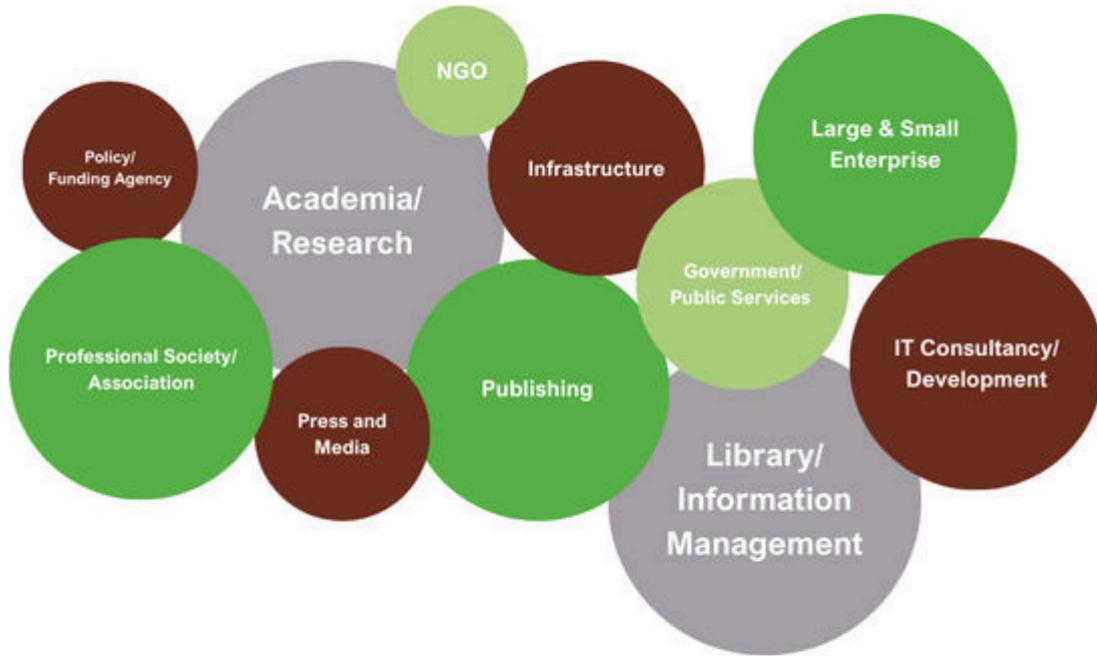
The OAB represents organisational interests within the RDA Council and ensures that their input and needs play a role in guiding the programmes and activities of the RDA.
